The driver must check tools and their condition before securing the load. In case of breakage, wear, missing or illegible labels, burns or other damage, the load securing straps must be discarded. A technical stop after the first 45' is recommendable to check that big bags have not moved and that straps have not loosened making sure that the load has not shifted. it is recommended to re-apply adequate tension as vibration may have caused the goods to change shape, rendering the tension initially applied ineffective.

5. Claims Period

The notification and reclamation deadlines set out in the CMR Convention shall apply, depending on the scope of application for cases of damage, loss, breakdown or delay.
